

2023-24.

Madam/Sir,

This is for your kind information that the RCI has granted approval to run D.Ed.Spl.Ed.(VI) course for the academic session 2021-22 to 2025-26 to your institute with maximum intake of 35 students. The approval was conveyed vide Council's letter No. 17-1394/D.Ed.Spl.Ed.(VI)/RCI dated 30/10/2021.

On receipt of the complaint, the Council conducted surprise inspection on 07/08/2023 and based on the surprise inspection report, approval for D.Ed.Spl.Ed.(VI) course has been withdrawn from the Academic Session 2023-24, as your institute has failed to secure minimum prescribed score in following parameters: (a) Building (51%) (b) Human Resources (66.1%) (c) Special School (22.1%) (d) Resource Room (33.3%) (e) Library Resources (61.6%) and curricular Transaction (45.6%).

Copy of the surprise inspection report is enclosed for your kind information.
